The 2017 OSHA refresher training program will help ensure that your employees receive the instructions and training they need to perform their jobs in a safe manner. The training will include a review of OSHA's:

- Bloodborne Pathogen Standard which applies to all employees who may have contact with un-embalmed bodies
- Formaldehyde Standard which applies to all embalmers who use formaldehyde-containing products
- Hazard Communication Standard which applies to all staff who handle hazardous chemicals and cleaning products
- The training will also include a discussion of compliance issues that are commonly found at funeral homes
