EXHIBIT FACILITIES/HOTEL FACILITIES

The Exhibition will be held at the Hilton Columbus at Easton.

Location Location

The Hilton Columbus at Easton has gone through extensive redesign completed in 2017 and is located in the heart of Easton Town Center's shopping, dining and entertainment. The Hilton is a AAA 4-Diamond Hotel located 10 minutes from the John Glenn Columbus International Airport. The Hilton has many upgrades to make your stay enjoyable: Ωthe new Herb n' Kitchen, Easton Social Lobby Bar, heated swimming pool, expanded fitness center, technology for the business traveler and free airport shuttle. Find shops, eateries, clubs and entertainment at Easton Town Center, just outside our hotel. Be sure to check out the Easton Town Center's website at www.eastontowncenter.com. The OFDA room rate is \$186.

FEE SCHEDULE

The booth fees and booth sizes are located on the floor plan (see floor plan on other side of this publication). Most exhibit areas are fully carpeted.

Vendors who wish to display a vehicle must also purchase a booth in the exhibit area.

Vendors will be charged the appropriate booth space rental fee and an additional \$500 per vehicle. There will be a designated parking lot area located at the North end of the Hilton.

OFDA has the right to limit the number of vehicles displayed per vendor.

Please note:

Only one booth is allowed per exhibitor.

EXHIBIT HOURS

Tuesday, May 22 - 4:30 - 7:00 p.m. (CCMS/PIMS Students 2:00 p.m.)

Wednesday, May 23 - 2:00 - 5:30 p.m. Thursday, May 24 - 8:00 - 10:00 a.m. n 2013 OFDA implemented a **Cumulative Point System** in order to assign booth space in a fair and unbiased manner.

This system will be used again for 2018. If your company has accumulated additional points in 2017, the points will be added to your current total. OFDA feels the point system is necessary due to the limited exhibit space available at the Hilton. Each vendor has been awarded points according to the following point system established by the OFDA Convention Floor Committee:

(2003 - 2017)

- One point for each year exhibited
- One point for each advertisement less than half a page in the Buckeye Director Magazine
- Two points for each advertisement half a page to full page in the Buckeye Director Magazine
- One point for each year sponsorship (all OFDA Events) up to \$1,000 annually
- Three points for each year sponsorship (all OFDA Events) \$1,001 - \$4,999 annually
- Five points for each year sponsorship (all OFDA Events) \$5,000 and over annually

To the best of OFDA's ability, the points have been tabulated for each vendor and are on file at the OFDA office.



EXHIBITING REPRESENTATIVES

- Each 6' display area will receive one complimentary registration
- Each 8' x 10' booth (8' deep and 10' wide) will receive two complimentary registrations
- Each booth space larger than 8' x 10' up to 16' x 23' will receive three complimentary registrations
- Each 16' x 23' booth will receive four complimentary registrations
- For each vehicle displayed you will receive two complimentary registrations

If you require additional name badges the fee will be \$95 for pre-registration and \$95 for on-site registration per name badge. (You will have an opportunity to register your name badges at a later date.)

STUDENT DAY

On Tuesday, May 22, students from CCMS and PIMS will be attending the convention and exhibition.

OFDA asks vendors to be available to students for early exhibit hours beginning at 2:00 p.m. (Students will be returning to CCMS/PIMS before the official exhibit hours have concluded).

SHARED EXHIBIT BOOTH SPACE

OFDA is offering the opportunity for vendors to share exhibit booth space with another vendor. If two vendors (there is a limit of two vendors in each exhibit booth) would like to join together in one space, each vendor would fill out an individual application for exhibit space indicating they are sharing with another vendor.

Each vendor's information will be listed in the Convention Pocket Guide. The cost will be the base fee of the exhibit space for the first exhibitor times 40% of that base fee for the second exhibitor (example: booth #7 is 8' x 10', base fee is \$795 first exhibitor and \$795 x 40% = \$318 for second exhibitor; totaling \$1,113 for the two vendors to share booth #7).

NOTE: It is up to the vendors to divide the booth cost; 50% of the total booth cost **MUST** be paid as a deposit with application for exhibit space.

SCHEDULED SET-UP TIMES

Monday, May 21, 2018

1:00 p.m. (Only booths numbered 1-7, 16-37 and 104-106 may set up at this time.)

6:00 p.m. (Booths numbered 8-15, and 38-103 may begin to set up **NO EARLIER** than 6:00 p.m.)

Refreshments and snacks will be available beginning at 1:00 p.m. to exhibitors setting up on this day, compliments of OFDA.

Tuesday, May 22, 2018

8:00 a.m. - 12:00 p.m. (Any booth may set up at this time.)

(A continental breakfast will be available at 8:00 a.m. to exhibitors setting up on this day, compliments of OFDA).

All exhibitors in the hallways must be fully set up and hallways cleared by 11:30 a.m. on Tuesday, May 22.

6' DISPLAY AREAS ONLY

6' foot display area booths are as follows: Booths 24-30, 37-47, 101-103 and 105. Included in the cost of the 6' display area on the exhibit floor is one skirted 6' table and one chair if you choose. You will ONLY receive the complimentary table and chair if the box is checked YES on the contract.



RULES & REGULATIONS

NON-EXHIBITOR SOLICITATION PROHIBITED

Solicitation is only permitted by registered vendors during scheduled exhibit hall hours. Non-exhibiting companies are prohibited from reserving meeting rooms, event suites or holding any event targeted to attendees during the Convention. Non-exhibiting companies and their representatives are not permitted to solicit within the exhibit hall, seminar rooms or other convention scheduled programming. OFDA further prohibits solicitation of business in any public areas occupied by the Convention, including public areas in the hotel, meeting rooms, suites and restaurants. All meeting space in the hotel is under contract to, and under the exclusive control of OFDA. Violators will be forced to cease current activities and will be subject to full exhibitor rental space fees. In addition, such conduct may result in the removal of all violators from the hotel premises.


If you would like to purchase electric or internet services for your display area, these services must be purchased through the Hilton. Information will be supplied to each vendor in the packet received from OFDA.

Enhance your exposure during the OFDA Convention.


