"Music License Only" and "Music Webcasting License Fee" NFDA offers the lowest rate available in funeral service

Music License

You are eligible for the \$243 "Music License Only" fee if you are a member of at least one of the following associations: NFDA, NFD&MA, OGR, SIFH, CANA or an NFDA federated state association (choice or partnership).

The three licensing organizations, BMI, SESAC and ASCAP, have your funeral home on file as previously having a music license. The 1984 U.S. Copyright Law requires a music license for all establishments. With NFDA, you pay only \$243 to avoid penalties of up to \$30,000. Don't take that risk. You'll have peace of mind through Dec. 31, 2015 in knowing you're not violating the law.

Webcasting License

While the music license covers performance, a different license is required for a funeral home to broadcast musical performances over the internet. Funeral homes that offer funeral webcasting services are violating copyright laws when they broadcast over the internet any funeral services that contain copyrighted music.

NFDA has finalized agreements with BMI, ASCAP and SESAC to a webcasting license that enables you to legally broadcast funeral services that include copyrighted music over the internet. With NFDA, you pay only \$47 per website to avoid penalties of up to \$30,000. You'll have peace of mind through Dec. 31, 2015 in knowing you're not violating the law.
